What is the Programming Grant?

The purpose of the Programming Grant is to provide funding for programs at affiliated institutions in order to help carry out the mission and vision of CAACURH.

Award will be given in the form of a reimbursement check (up to \$500.00) to the receiving institution. The institution must hold a program and submit all receipts to the ADAF by March 1st of the same affiliation year to receive reimbursement. The institution must also submit a wrap-up report to the ADAF within 30 days of the program's conclusion.

Application Questions

Briefly explain the structure of RHA and NRHH (if applicable) at your institution.

RHA at the University of Toledo has seven executive board members with two advisors, and each residence hall on campus has a hall council with a various number of members. This year, the amount of general body members has increased from last year, and the amount of people attending our programs are drastically increasing. Unfortunately, the University of Toledo does not have a NRHH, but there is some interest in bringing NRHH back to the University of Toledo.

Please provide a summary of the program your institution would hold if awarded this grant.

We are planning to do a Murder Mystery Dinner. The name of the mystery is "Murder Mystery at the Ugly Sweater Party". Up to thirty residents and our executive board members will play as characters and answer clues to figure out who the killer is. Also, RHA is adding alcohol and drug education in the murder mystery. For decorations, there will be facts about alcohol and drugs, and in order to answer a question/clue for the murder mystery, participants have to answer a question correctly about alcohol and drugs. This is a new program that RHA at the University of Toledo is putting on for the 2019-2020 school year.

Please provide an estimated budget for the proposed program.

While this grant is limited to \$500.00, this question is for consideration of financial responsibility only. Links to spreadsheets are acceptable responses.

For the Murder Mystery dinner, we are providing Bob Evans to the participants. Since up to thirty residents, seven executive board members and two advisors will be present at the murder mystery dinner, we will have to purchase food for forty people. Four platters (each serving 10 people) will be purchased at \$109.99 each. The total amount for the food is \$439.96, with a 20% gratuity bringing the total cost to \$527.95.

The Central Atlantic actively seeks to "Prioritize People and Experiences." Please explain how the proposed program aligns with this effort.

RHA is incorporating alcohol and drug education in this murder mystery dinner. It is important the college students know about alcohol and drugs, and what the consequences may be from alcohol and drugs. Also, the murder mystery is a fun way to learn about how alcohol and drugs can cause a negative impact, but also learn about everyday situations and the statistics from alcohol and drugs. The murder mystery dinner not only provides a fun experience at the time, but can help participants learn about safer experiences in the future.
